Membership fees will be waived for 2023.

### RULES OF THE MARKET

- A copy of the required certification/licensure (e.g.: meat handler, baked goods, canned goods, etc.) must be submitted with the application.
- Food Trucks must be in compliance with North Carolina and Chatham County regulations. A copy of the required certification/licensure must be submitted with the application.
- Raw goods must be grown or made in NC.
- Crafted or processed goods must be made in NC.
- All products must have proper signage (e.g.: price list) including the price, product name, and where the product was made.
- If products are being re-sold, credit must be attributed to the original producer (ex: Black Beauty zucchini grown by Honeybee Farm in Asheboro, NC).

All new applicants must have a farm or site visit by a board member before being accepted to the market. Please understand that it may take up to two weeks for us to process and respond to your application before doing a site visit or approval of application.
